- g) When completed, you will be asked to provide information which will be e-mailed to Crowder College to verify you have completed the Entrance Counseling. You will be given a confirmation number, please record it and the date on the front of this application in step 1.

### 7) Loan Eligibility Amounts

#### Can I borrow both a Subsidized and Unsubsidized Stafford Loan?

Yes. You may borrow from both programs as long as the combined loan amount does not exceed the maximum allowed per grade level. Federal regulations require you to apply for the subsidized loan first. Any additional eligibility will be an unsubsidized loan but cannot exceed your total cost of attendance minus the combined financial aid you are receiving.

**Grade Levels:** 1<sup>st</sup> Year = 0-29 credit hours completed    2<sup>nd</sup> Year = 30 or more credit hours completed
